## **Membership renewal reminder – Heather Pitch, Membership Secretary**

If you haven't already done so, now's the time to renew your Club Membership. Fees were due on 1

November 2018 and anyone who has not renewed by 31 January 2019 will be deemed a lapsed member and will have to pay a £5 re-joining fee. In addition, they will lose their BDI cover until 40 days after outstanding fees are paid.

This year we are asking all tax-paying members to complete a new Gift Aid declaration due to changes in the required wording. This will then apply for future years unless your circumstances change. ## **Free money from the Taxman - Importance of Gift Aid to NSBK's funds – Tony Slater, Branch Treasurer**

I thought that if a member completed a Gift Aid form, it would increase the funds going to the NSBK by 25%. Not bad, as it's free money, but I was surprised to find that the percentage is much higher than this.

The reason is that while a considerable slice of membership fees goes to the BBKA (to pay for the main

insurance and publications etc) none of the Gift Aid repayment is passed on to the BBKA.

Have a look at the chart below. A typical membership subscription is £37. You will see that out of this, £19 goes to the BBKA, £5 to Avon Beekeepers Association (the registered charity of which we are a branch) and £2 is spent on the mandatory bee disease insurance. This leaves just £11 for NSBK funds. However, if the member is able to complete a Gift Aid form, then because the BBKA does not share in the tax repayment, we receive a further £6.94, an increase in our funds of 63%.

All it takes to complete it is your name and address, date and signature. You don't need any tax reference or NIC numbers.

Send the completed forms to the new membership secretary, Heather Pitch, either by email or post, as described above.

If you have completed a form, but not in the last 12 months or so, could you please do another one. The format has changed a little and we want to make sure the claim records are completely up to date. We don't want to fall out with HMRC if they audit the Gift Aid claim!

One other point to remember is that Partner Members (members who reside at the same address as a Full Member and thereby pay a smaller subscription) need to complete a Gift Aid form of their own as well as the Full Member.

**How about studying a BBKA module? – Paddy Brading**

Now that the bees are bedded down for the winter it might be a good time to think about studying for one of the modules offered by the BBKA. These modules are a great way to gain insight into all aspects of beekeeping and increase your knowledge and understanding of the ways of these fascinating insects. There are 7 modules which can be taken in any order except module 8 which must be studied last.
